The following information is included in the application:

- Government Issued Photo ID of Relative/ Family Friend (proof of age)
- Proof of address (if not on the Gov't ID)
- Signatures of Natural Parent, Homestay & School Coordinator
- If flying, the Student's Plane Ticket (should be purchased after getting trip approval from ISP Dep't)
- If flying alone for part of the trip, a letter from Natural parents stating that the student can travel alone from YVR to relative/close family friend.
- Proof of additional insurance (students on MSP, if travelling out of BC)
- For high-risk activity, a company waiver signed by the natural parent

The student must take the following on the trip:

- BC Medical Card
- guard.me Card (valid in Canada & US)

In addition, if flying and/or travelling out of Canada the student must take the following valid documents:

- Passport
- Study Permit
- LOA
- Letter from Natural parents stating that the student can travel alone and/ or to the US (out of Canada)
- Travel visa, if necessary
- Custodian document
